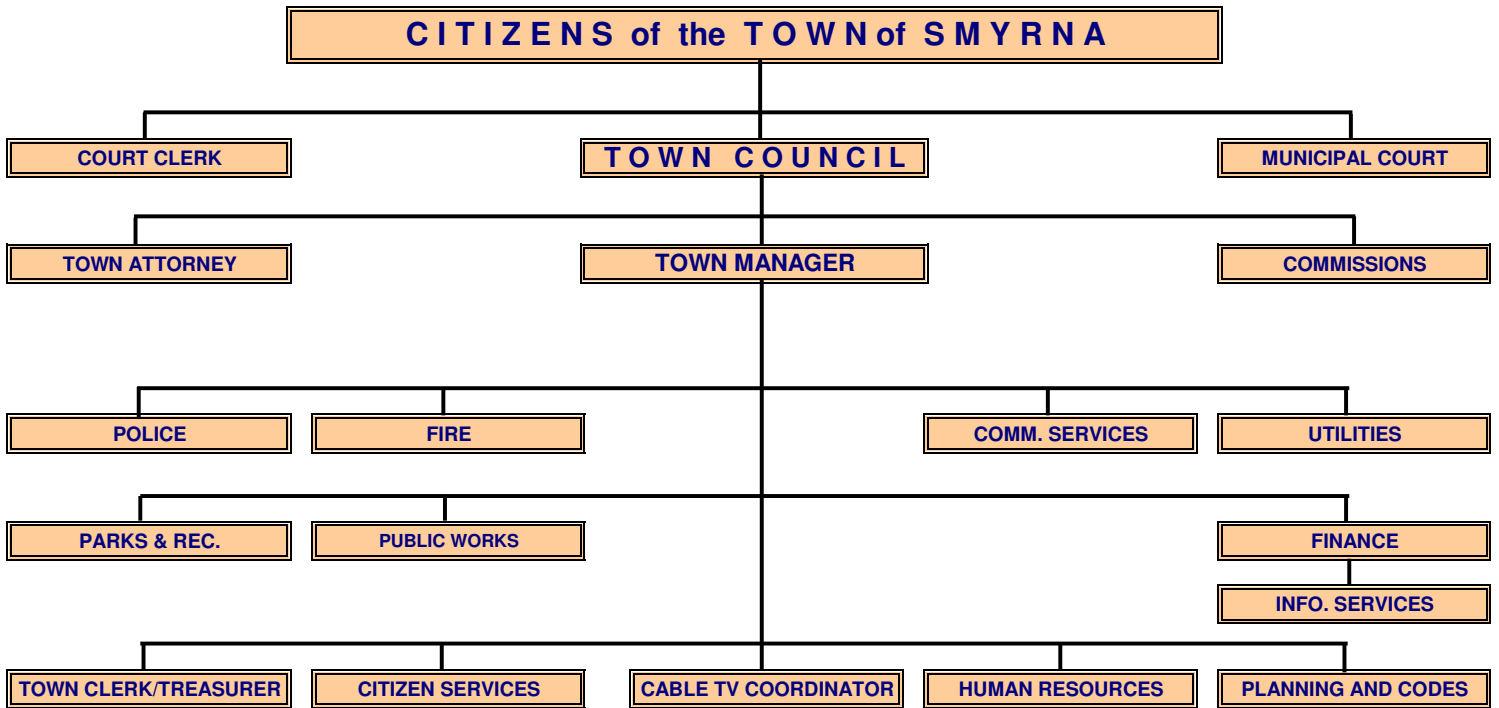

ORDINANCE NO. 05-24**

**AN ORDINANCE** adopting the budget for the fiscal year beginning July 1, 2005 and ending June 30, 2006.

**BE IT ORDAINED** by the Town Council of the Town of Smyrna that the budget document attached hereto and incorporated herein by reference as if set forth herein at length verbatim be, and it hereby is, adopted and approved by the Town Council and that the amounts set forth therein be, and they hereby are, appropriated for the purpose of meeting the expenses of the various funds, departments, institutions, offices and agencies of the Town of Smyrna, Tennessee during the fiscal year beginning July 1, 2005, and ending June 30, 2006.

**BE IT FURTHER ORDAINED** by the Town Council of the Town of Smyrna that this Ordinance shall take effect from and after its adoption on second and final reading and its provisions shall be enforced from and after July 1, 2005, the public health and welfare of the Town of Smyrna requiring it.

**PASSED** on first reading by the Town Council the 31st day of May, 2005.

**PASSED** on second reading by the Town Council the 14th day of June, 2005.
