



SINGLE FAMILY RESIDENTIAL PERMIT

Steps to Request Permit

1. What to bring

- Development Tax Receipt – paid at Rutherford County
- Estimated Construction Cost
- Current copy of Tennessee Contractors License (not necessary if already on file)
- Current copy of Workers Comp Certificate (not necessary if already on file)
- Copy of Current Town of Smyrna Business License or Business License release form obtained from Treasury Department
- If Homeowner is obtaining their own permit acting as their own contractor, a TCA form is required to be completed stating that owner will be restricted from constructing another residence for personal use for a period of two years.

FEES

2. Development Tax

- Paid at Rutherford County in Murfreesboro - #1 South Public Square
- Call Rutherford County Codes Department for amount – (615) 898-7734
- Pay before permit & bring “Paid” copy of Development Tax to Smyrna

3. Permit Fees

- Permit Fees – Residential
 - Residential Fee - **\$.35 cents** per square foot – (minimum \$30.00)
 - Requires a separate electrical permit – for info call (615) 355-5704

4. Utilities Tap Fees

- Gas, Water, Sewer – Call Utilities Department (615) 355-5740 for amount
 - Fee must be paid when Building Permit is obtained.

5. Electrical Permits

- Separate Permits are required for Elec/HVAC - Call (615) 355-5704

6. Impact Fees

- Fee must be paid when Building Permit is obtained.
- Must be on a separate check from the permit & tap fees.
- Fee is: Single Family - \$2,708.00; Multi Family - \$1,824.00 per unit; Mobile Home - \$1,672.00
